

C-WAGS League

Side By Side Dog Training will be hosting a C-WAGS Obedience, Scent and Games League beginning February 25, 2020 and continuing on March 3, 10, 17, 24, and 31, 2020. The League Banquet will be April 7, 2020; location and time to be determined.

The league will be limited per night at the host's discretion. All courses/classes will be designed and judged by a C-WAGS judge under current C-WAGS rules. Therefore, all qualifying scores will count towards C-WAGS titles.

FEO is offered for all classes. All FEO's must be registered by the end of the business day on the Monday before league play. Late regular entries will be accepted as long as they are received by the end of the business day on the Monday before league play. There will be no day-of-league entries.

There will be qualifying ribbons for each qualifying run. At the end of the six-week league, we will award placements in each level and title, championship, and master ribbons. There may also be non-score related awards given.

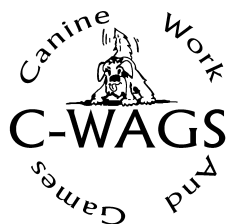

C-WAGS Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS Obedience & Rally rules and regulations including but not limited to the following rules regarding entry:

- ♦ All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- ♦ All judges and trial hosts are expected to show respect to all exhibitors.
- ♦ This trial is open to all dogs registered with C-WAGS.
- ♦ Trial Hosts may elect to accept FOR EXHIBITION ONLY entries of non-registered dogs.
- ♦ Teams may be entered in multiple levels/classes at the same trial.
- ♦ Dogs must be shown by a member of the owner's immediate family.
- ♦ Collars: The dog must wear a flat type collar (buckle, snap or proper fit martingale) and/or body harness in the ring. Electronic training collars are not allowed on the show grounds.
- ♦ Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge
- ♦ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

In addition,

- ♦ The organizing committee may refuse any entry for any reason.
- ♦ THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- ♦ Refunds will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.
- ♦ Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made by money order within 7 days of notice to exhibitor of returned check. Any fees not received within 7 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
- ♦ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- ♦ Dogs must be on leash while on show grounds unless being shown.

C-WAGS League play:

League will consist of 6 mini-trials (subject to postponement due to unforeseen circumstances, weather, etc.). There are a variety of classes offered during the league. FEO is at the host's discretion.

All courses will be designed and judged by approved C-WAGS judges and all scores will count towards titles.

All dogs must be registered with C-WAGS to participate. (You may turn in your C-WAGS registration with your league entry. Online registration and paper registration form available at www.c-wags.org. Forms also available from host.)

Debit/credit card payments accepted via PayPal. Please contact trial host to set this up.

Qualifying ribbons will be awarded to all qualifiers. Placement, level title, championship title, and master title ribbons will also be awarded upon completion of the league. Additional awards may be granted at the discretion of the host club.

Walk-through/briefing for the first class begins at 6:30 p.m. with first dog on the line at 6:40 p.m. Second class (second column) will not begin any earlier than 7:15 p.m. Other classes to follow. All crating is in your car or outside of the building. No late walk-throughs unless extenuating, unique circumstances.

As in any other trial, all registrations are final and may not be adjusted or traded unless you are moving up. Late and FEO registrations must be received by the end of the business day the Monday before league play. No day of league entries will be taken.

Team Games – from the C-WAGS rules: The Team Game classes will consist of 18 – 24 exercises on a rally course. The team will consist of two dog and handler teams. The object will be for one dog and handler to complete a designated half of a rally course while the other dog maintains a stay position (Honor exercise). Upon the first dog's completion, the second dog will complete the second half of the course while the first dog maintains a stay position *(Honor exercise). **Please check the rules for more information!

Registration fee for Team is \$5/dog before 2/20/2020 and \$8/dog after.
